Textual Information()

There was inter se transfer of 4,35,002 Equity shares through off-market transaction by way of gift on 16.03.2020 between promoters of the company i.e. Mrs. Hemlata Jain acquired 3,45,000 Equity shares from Mr. Akash Jain(Son) and 90,002 equity shares from Mrs. Sheetal Jain (Daughter in law) respectively in terms of gift deed . Consequently the total shareholding of Mrs. Hemlata Jain has increased from 6,69,820(18.11%) to 11,04,822(29.87%). Further total Shareholding of Mrs. Sheetal Jain decreased from 1,90,002(5.13%) to 1,00,000(2.71%) and total shareholding of Mr. Akash Jain decreased from 3,45,000 (9.33%) to Zero(0.00%) However the total holding of the promoter group of the company is 22,96,090 (62.09%) before and after the inter se transfer of shares through gift remains same. All the necessary disclosures as per Regulation10(5),10(6), 10(7) and Regulation 29(1)& (2) of SEBI (Substantial acquisition of Shares and takeovers) Regulations, 2011, Regulation 7 of SEBI (prohibition of Insider trading) Regulations, 2015 have been complied with accordingly.
